



## CHILDREN'S POLICY ACCESS CHILDRENS UNDER 18 YEARS OLD

**THE FOLLOWING AUTHORISATION MUST BE COMPLETED AND SIGNED AT THE ENCLOSURE DOOR FOR ACCESS OF MINORS TO THE FESTIVAL TOGETHER WITH A PHOTOCOPY OF BOTH THE PARENT'S/ PARENT'S/LEGAL GUARDIAN'S IDENTITY CARD OR PASSPORT AND A PHOTOCOPY OF THE MINOR'S/ MINOR'S IDENTITY CARD OR PASSPORT.**

★ Minors under 16 years of age (inclusive) must always enter the festival accompanied by an adult (parent or legal representative), who will be responsible for the actions that the minor carries out within the event in accordance with the provisions of the Criminal and Civil Code. Likewise, they must have a ticket to access the venue.

Children under the age of 14 can access the festival free of charge, always with a child ticket purchased together with an adult ticket during the purchase process. Maximum one child under 14 years of age per adult.

★ Those over 16 but under 18 may go unaccompanied, but must still present at the entrance of the venue the signature of this authorisation admitting their responsibility in the actions carried out inside the venue on the basis of what is regulated in the Penal and Civil Code. Likewise, they must have a ticket to access the venue.

**In all cases, both father/mother/guardian/authorised person, when signing this document and presenting the photocopy of DNI/NIE/Passport declares:**

- To be in full knowledge of the conditions of purchase and sale of the tickets exposed to minors and accepts them without restriction.
- Likewise, he/she declares to be fully and solely responsible for the protection and custody of the minor/ minors mentioned in the document and undertakes to ensure their safety and well-being during the festival and during their stay at the venue.
- Assumes the responsibility to prevent the consumption of substances such as alcohol, tobacco or narcotics by the minor(s) mentioned in this document; and to avoid any situation of risk or danger to the minor, or which he/she may cause.
- To act with the diligence required in the care and custody during the artistic performances, placing the minor/s in safe places.
- To exempt the company organising the event from any liability for any damage and/or harm that minors may suffer or cause, and to proclaim that they are solely responsible for the aforementioned damage and harm.
- Consent to the organising entity not to reimburse the price paid by the parent/guardian/authorised person and by the minor when entry to the site is denied due to failure to provide the correct and necessary documentation or, if applicable, due to failure to comply with any of the conditions assumed, the minor is required to leave the site.
